

## CYCLE MONITORING FOR OTHER CLINICS

### GENERAL INFORMATION

We are happy to assist with the monitoring of cycles at other clinics because we realize this will help to reduce the cost, time commitment and stress associated with the treatment cycle. However, we do not have any financial arrangements with other clinics, so we must bill you for each of the services we provide. For your convenience, there are 2 payment options available

*Option 1:* Genesis secures a credit card number from you before the start of your cycle monitoring. Each service will be automatically charged to your credit card and a receipt will be mailed out to you each time a service is provided to you.

*Option 2:* A deposit of \$1500.00 is made to Genesis before the start of your cycle monitoring. Each service will be deducted from this deposit at the time it is rendered. When your monitoring is completed, any remaining balance will be refunded to you along with a detailed receipt.

A finance clerk will be contacting you to discuss your choice of payment *prior* to your cycle monitoring start.

Because every clinic uses slightly different treatment protocols, we ask that you and your other clinic provide us with clear instructions about the process. This includes information about the timing and nature of the monitoring you will require and instructions on how to send the results to the other clinic. We will rewrite prescriptions sent to us from the other clinic so they can be filled in B.C. Your clinic needs to provide us with accurate, written information about the drug name, dosage, or strength and quantity needed. We can only fill prescriptions that are the same as those used in our clinic. The prescriptions can also be rewritten by your family physician here.

To ensure consistency and the best possible care, please note that questions about the organization of your cycle, success rates, interpretation of blood test results and other cycle-specific queries should be directed to the clinic where the cycle is being conducted, not to the staff at Genesis.

*Please note: Elective cycle monitoring will not be provided on Saturday, Sunday or Canadian Statutory Holidays.*

### FEE SCHEDULE FOR CYCLE MONITORING AND ON-GOING CYCLE MAINTENANCE

Nursing telephone consultation (mandatory for each cycle initiated)	\$ 75
Blood tests (for EACH hormone measured: estradiol, progesterone, FSH, LH, etc.)	\$100 each
Vaginal ultrasound	\$135 each
Provide rewritten prescriptions	\$ 20
One-on-one injection teaching (IM or S.C. injections)	\$ 50 per ½hour
Administration of daytime injection	\$ 20 each
Use of nursing pager for non emergencies	\$ 50
